Nomination Guidelines

1. Nominations should be submitted confidentially without advance publicity or petitions used to promote nominations.
2. Nominees do not need to be residents of St. Clair however their qualifying accomplishments should have clearly benefited the St. Clair Community and/or its citizens.
3. Nominees can be a man or woman however they must be alive as these awards are not given posthumously.
4. Nominations are not carried forward from year to year. If you have previously submitted a candidate who was not selected, please update any information and re-submit
5. Nominations should be submitted in a sealed envelope to the Chamber Office no later than **May 21, 2021. The outside of the envelope should be clearly marked with the Award Category for which the nomination is being made.**
6. Nominations are to be made only on the form supplied by the Chamber of Commerce. Additional forms will be supplied upon request by visiting the SCACOC office, by email request to chamber@stclairmo.com or visit to the website www.stclairmo.com. Anonymous nominations will not be considered.

Award Categories

Business of the Year

In recognition of...outstanding dedication and support to the St. Clair community and/or significant business achievement during the previous year.

Citizen of the Year

In recognition of...unique and distinguished record of community service...Qualifying accomplishments should have clearly benefited the St. Clair community... must be outside of their normal work duties where citizen has gone above and beyond...possessing a true spirit of volunteerism should also be a consideration.

Organization of the Year

In recognition of...outstanding service and support to the St. Clair community and its citizens... through projects, services, events, scholarships, etc. (This may be profit or non-profit organization).

Spiritual Leader of the Year

In recognition of... community service through Spiritual Leadership. Nominees do not need to be ordained ministers however the qualifying accomplishments should have contributed to the spiritual well-being of the St. Clair Community.
